

Contest rules "CQ VOJVODINA"

The "CQ-VOJVODINA" contest is held in honor of the birth date of our great scientist and humanist Mihajlo Pupin (09.10.)

- 1. Organizer:** Amateur radio-union of Vojvodina.
- 2. Participants:** All licensed radio amateurs who wish to take part in contest.
- 3. Date:** Third Friday in October.
- 4. Time:** 17.00 to 17.59 UTC.
- 5. Periods:** 17.00 to 17.29 CW and 17.30 to 17.59 SSB.
- 6. Frequency:** 3510-3560 CW and 3650-3770 SSB
- 7. Transmitter power** according to the class specified in the license.

8. Categories:

Stations from Vojvodina:

- MIXV – CW + SSB
- SSBV - Only SSB
- CWV – Only CW
- MLDV- Youth up to 25 years old – only SSB

Stations outside Vojvodina

- MIX – CW + SSB
- SSB - Only SSB
- CW – Only CW
- MLD- Youth up to 25 years old –only SSB

- Competitors who are 25 years old or younger, on the day of the contest, take part in the MLDV and MLD categories. The Contest Committee has the right to ask competitors in these categories for proof of age.
- Competitors up to 25 years old can participate in MIX or CW categories if they wish.
- One station can participate only in one category.
- A competitor can work in both periods and register in only CW or only SSB category.

9. Exchange:

- All stations from the territory of Serbia sent RST + serial number starting at 001 (increasing by 1 for each subsequent QSO and continuing in the second period) + car registration mark of the area from which they work (2 letters).

- Stations outside of Serbia sent RST + serial number starting at 001 (increasing by 1 for each subsequent QSO and continuing in the second period) + "NY" mark.

- In CW period call with "CQ VOJ" and in the SSB with "CQ VOJVODINA"

10. Scoring:

Each correct QSO CW brings 2 points and SSB 1 point.

- Points for QSO with station where the working time differs by more than 3 minutes will not count.
- Points will not be counted for QSOs with stations that appears in less than 20% logs per period.

11. Multipliers are different car registration marks from the territory of Vojvodina and are counted once in each period. The own multiplier does not count. List of multipliers is at the bottom of these rules..

12. The final result is obtained:

- For MIX and MIXV categories, the sum of the product of QSO points and multipliers from both periods.
- For only SSB and only CW categories, the product of QSO points and multipliers in the SSB or CW contest period.
- The competitor is not obliged to have the correct calculated result in the log header. "Robot" will correctly calculate the achieved result.

13. The contest log is sent exclusively in CABRILO format to the server for receiving logs (robot) at the address https://radiosport.yu1srs.org.rs/HF/index.php?option=com_content&view=article&id=107&Itemid=187&lang=en no later than 3 days after the end of the contest, namely until Monday at 23.59 UTC. In case of impossibility to send the log via "robot", send the log to the e-mail address radiosport@yu1srs.org.rs When sending the log, it is mandatory to put the call sign and the category in the SUBJECT line. (examples: YU7WW MIXV, YU4CCC SSB, HG5A MIX...).

14. Results

Claimed results will be published no later than 5 days after the deadline for sending the log, and unofficial results no later than 20 days after the day of the contest. Any complaints about unofficial results can be submitted within 3 days after the unofficial results are published via e-mail address radiosport@yu1srs.org.rs. The official results will be published after resolving appeals, if any.

15. Awards and recognitions

The first-place winner in each category receives a plaque or trophy, and the others receive a diploma in PDF format with an indication of their placement. Stations that send a log as checklog will receive a diploma for participation in PDF format. Trophies or plaques will be ceremoniously presented at the SRV Assembly or in some other way.

16. The Contest Committee recommends audio recording of the contest.

In the case of possible appeals, an audio recording of the disputed QSO, a recording of the next QSO and a recording of the QSO preceding the disputed QSO shall be submitted. It is necessary that one's own audio record and the audio record of the correspondent can be heard completely and legibly. In disputed cases, the decision made by the Contest Committee is final.
